### **New Functionality**

### APTAWEB-2627: Redesign – Move Save/Cancel/Other Action buttons Moved to Upper Right

Over the course of the next few updates, the buttons that cause action in AptaFund will move from the lower left to the upper right of the page. These action buttons (Save/Cancel/Submit, etc.) should be more visible and easier to use (see the pictures below for examples). In this update, only the detail screens will change. The main grids will be coming in the next release. Users will notice that one button is a different color. This is the default action button on the screen.

### APTAWEB-2798: Ability to Exclude a Deduction from a Register for All Employees

AptaFund users now have the ability to remove or add deductions on an entire register. Doing this will include or exclude deduction(s) for all employees on the register who have it. To include or exclude deductions on the whole register, click the **Include/Exclude Deductions** button to open the *Deduction Selector* popup box (below). Select the deductions to include or exclude and choose the proper button.

## **Fiscal Year End Issues**

### APTAWEB-3036: Rollover Chart of Accounts Added to Job Queue

Since the rollover Chart of Accounts command may take some time to complete, the process has been added to the Job Queue. AptaFund will notify the user that the job is in the Job Queue and will alert the user when it is complete. While it is running, the user can continue to use AptaFund, although some parts of the database may be locked out while the rollover is working.

### APTAWEB-3039: Label on Bank Account Rollover Popup Changed

The label on the *Bank Account Rollover* popup page for the new fiscal year has been changed to "New Accounting Cycle", and the default year in that box is the new fiscal year.

### APTAWEB-3040: Completion Message Appears When Banks are Rolled Successfully

A "Bank accounts rolled over successfully" message now appears on the screen when the bank account rollover is complete.

### APTAWEB-3041: Popup Dialogs Added for HR Rollover Tasks

Popup dialog boxes which ask the user to choose a New Accounting Cycle now appear for the following rollover processes:

- Human Resources > Rollover Calendars
- Human Resources > Rollover Salary Schedules
- Payroll > Rollover Leave Types

### APTAWEB-3042: Completion Message Appears for Calendar Rollover

The completion message on the Human Resources Calendar rollover now says "Calendars rolled over successfully."

### APTAWEB-3045: Completion Message for Master Position Rollover More Complete

The completion message on the Master Position rollover now displays in a grid which shows master positions which succeeded as well as exceptions.

### APTAWEB-3047, -3048: Progress Icon, Error Messages Added to Rollover Employee Jobs Dialog

Added a "spinner" icon to appear after the user clicks the **OK** button on the *Rollover Employee Jobs* dialog box. The icon will remain on the screen until the rollover is complete. If there are any errors, those errors will display in a red bar on the top of the page.





## **Fiscal Year End Issues**

### APTAWEB-3212: Rolling Over Payroll Cycles

Added a **Rollover Payroll Cycle** button to the *Payroll Configuration Payroll Cycles* tab. Users can roll over the payroll cycles to the next fiscal year. Employees who are members of payroll cycles in the old fiscal year will remain there in the new fiscal year.

### APTAWEB-2953: Auto-Roll Payment Plans

AptaFund now rolls over employee job payment plans automatically, so that users do not have to change the pay plan for each employee every year. For example, if an employee is on a pay plan of "Evenly Over 12 Periods" in the old fiscal year, the pay plan in the new year will also be "Evenly Over 12 Periods" when the job is approved in the new year. The only time this will not happen is when the payroll cycle changes from one year to another (e.g., Monthly to Semimonthly).

### APTAWEB-3050: Mass Approve Jobs Page Updated with Result Messages

Success or Failure messages now appear on the *Mass Job Approve* page when the process is complete.

### APTAWEB-3049: Success Message Added to Rollover Leave Types Page

A success message which reads "Leave types have been rolled over successfully" now appears on the *Leave Types* tab when the leave types are rolled over.

### APTAWEB-3051, -3052: Deduction Assignment Progress Icon Added and Button Changed

The button to rollover deduction sets on the *Deduction* Assignment page is now called **Rollover Deduction Sets**. Also, this update added a "spinner" icon to the *Rollover Deduction Sets* page, which appears after the user clicks **OK**. When the rollover process completes, the icon disappears and a success/failure message appears.

### APTAWEB-3097: Fixed Rollover Functionality on Deduction Assignment Page

Users can roll over employee deduction sets on the *Deduction Assignment* page by clicking the **Rollover Deduction Sets** button. All employees who have an approved job in the new fiscal year will have their deduction sets rolled over into that new fiscal year.

### APTAWEB-3053: Fixed Rollover Leave Balances Process on Employee Payroll Information Page

Fixed issues in the Rollover Leave Balances process so that leave balances come across to the new year correctly.

### APTAWEB-1614, -2804: Sort Order Issues on Check Printing Pages

Some changes have been made to the Check Printing screens in Payroll and in Accounts Payable:

- Payroll Liability Checks and Accounts Payable Warrants sort by Vendor Name by default.
- Employee Paychecks and Direct Deposits sort by Display Name by default.
- Users can change the default to a different column in Grid Settings (clicking the 🔪 icon).
- If a user checks the Select All box, checks will print in the same order in which they were sorted.
- If a user selects multiple checks (i.e. clicks individual checks or warrants), checks will print in the order the checks were <u>selected</u>, and **not** by the sort order.

### APTAWEB-2173, -2176: Grid Settings – Page/Report Settings for All Grids

All Grid Report Settings (found on the menu in the upper right of each grid) has a place for the user to name the report, as well as options like page size, orientation, and margins. Once these settings are applied, they will stay in effect for all Grid Reports on that particular page.

The "Session has timed out" page has been removed. If a user is idle for more than 20 minutes, AptaFund will return to the Login page. Upon logging in again, the user is taken to the same page before the timeout occurred.

### APTAWEB-3092: AptaFund Logo is a Link to the Home Page

The AptaFund logo in the upper left of every page is a link to the Home page (<u>https://www.aptafund.com</u>). Clicking on the logo will take the user back to Home.

### APTAWEB-3151: Generating Reports to .CSV File Saves Time on Large Reports

AptaFund reports have a new button option to (Comma Separated Value). This will still open the report in Microsoft Excel, but it will not have the same formatting as an Excel report. The benefit of the lack of formatting will cause the report to generate much faster, especially large reports like the *Fund Audit Report, GL Detail Report, Account Journal Activity Report,* and *Payroll Register by Paycheck Report.* 

### APTAWEB-3172: Grid Settings Save between Visits to the Same Page

This update fixed issues with Grid Settings not being saved properly when re-visiting the same page.

### APTAWEB-3218: Installation Name Added to All Reports

The Installation Name (which can be found on the *System Configuration* page in the Administration module) has been added in the header to all reports in AptaFund.

### APTAWEB-2970: Ability to Rollover Employee Contracts

Users now have the ability to rollover Employee Contracts. The Employee Contracts page in the HR,

Payroll & ESS module has a new Rollover Employee Contracts button, which will allow the user to roll any selected contracts to the next fiscal year. When at least one schedule is selected, and this button is clicked, the *Rollover Employee Contracts* dialog appears. The user selects the new fiscal year and clicks **OK**. These contracts will then be available on the *Employee Contracts* page in the new year.

### APTAWEB-2995: Set Max Logo Size on Employee Contracts

The user can now set the maximum logo size on the employee contracts on the *Employee Contracts* page. When a logo is selected in the Logo drop-down, two fields appear for maximum length and width. These dimensions are in inches. The logo will not be expanded to fit dimensions that are larger than actual size. For example, if the logo is two inches long by one inch tall, those are the maximum dimensions that the logo will print.

### APTAWEB-3000, -3001: Show Bookmarks in a List in the Employee Contract Body Elements

All contract bookmarks are now included in a frame on the right side of the Body elements dialog box. These bookmarks are custom to the checkboxes selected for "Include All Jobs of this Contract Type" and "Include Jobs from Other Contact Types". The bookmarks can be added to the contract verbiage by placing the cursor where the bookmark should be and clicking the name of the bookmark.

### **APTAWEB-3131: Header/Footer Removed From Employee Contracts**

This update removed the "Header" and "Footer" boxes from the *Employee Contracts* page. Instead, the "Page Header" and "Page Footer" boxes remain for users to configure how the contract header and footer sections. This will prevent confusion and allow for more space on the contract itself.

### APTAWEB-3044: Improved Grid View on Salary Schedules Page

Redesigned the schedule grid on the *Salary Schedules* tab so that it will display more salary schedules. The upper grid is now of the same height as the bottom grid, and users should be able to see four salary schedules at one time.

### APTAWEB-604: Incrementing Step and Applying New Salary Schedule Simultaneously

Users can now increment the Salary Schedule step for selected employees at the same time changes to the Salary Schedule are applied. This takes place on the *Human Resources Configuration – Salary Schedules* page. When the user makes changes to the Salary Schedule (e.g., changes the Base Pay or the Step Amounts), the schedule must then be applied for the new amounts to take effect. Now, the user

can also increment the salary schedule step by clicking the Mass Increment Salary Schedule Step and Apply Schedule button. Doing this will call up the Increment Salary Schedule dialog, where the user can choose which employees to increment. After this, the Apply Salary Schedule dialog will appear, which allows the user to create Retroactive Pay, if necessary.

### APTAWEB-3144: Locked Job Name Field once Employee is Assigned that Job

Once an employee is assigned a particular job on the *Employee Job Details* page, the Job Name field cannot be changed (once the Save button has been clicked). If the job was assigned in error, it must be deleted and the correct job added.

### APTAWEB-3153: Employee Photos Expand when Hovering

When the user hovers the mouse cursor over an employee's photo on the *Employee Details* page, the photo will enlarge from a thumbnail to a more visible size.

### APTAWEB-3274: Removed Error when User Vacates Position

This update removed the error "Object reference not set to an instance of an object" when vacating a job on the *Employee Job Details* page.

### **APTAWEB-3168: Added Origin for Accounts Receivable Entries**

Previously, when an Accounts Receivable (AR) bill schedule was posted, the Origin field on the *Journal Entry* page was blank. This issue has been fixed. Now, when creating a new bill schedule, adding and posting a new bill item, the *Actual Journal Entry* will show with "A/R" in the Origin field.

Command buttons on the *Element Value Maintenance* page (such as **Set Fund Classification, Assign Balancing Accounts To Fund**, and **Change Required Elements For Fund** appear only when the appropriate element is selected from the "Select Element" dropdown. For example, the **Set Fund Classification** button will not appear if the Fund element is not selected.

### APTAWEB-3136, -3137: Fixed Account Code Helper

On the Vendor Invoice Detail page, the Account code helper now delivers the proper accounts on searches based on the user's input. It is also working for singular account code entry and allocation.

### APTAWEB-3141, -3181, -3197: Removed Errors when '#' Symbols are Used

If no Order Receipt exists for that item, a message will appear indicating that the Order Receipt is not available. Please note that the user must have permissions to see the *Order Receipt* page in order to view it.

### APTAWEB-2715, -2717, -3074, -3100: Enhancements made to Asset Management and Related Pages

Enhancements include:

- Improved row height and column width
- Correct bread-crumb navigation (at the top left of the page)
- Keyboard shortcuts added for Asset and Asset Detail pages:
  - o "A" key will open the Add popup
  - o "E" key will open the Edit popup (will Edit All if multiple records are selected)
  - o "Esc" key will escape from the popup window
  - o "Alt + S" saves the record (once mandatory fields have been filled in)
  - o "Alt + M" adds the current record and opens another new record
  - o "Alt +  $\rightarrow$ " or "Alt +  $\leftarrow$ " redirects between multiple records.

#### APTAWEB-2858: W-2 Sub Code Follows W-2 Box Field When Necessary

The "W-2 Box" and "W-2 Subcode" fields on the *Manage Deductions* page are now integrated with each other. Choosing a W-2 box which requires sub-codes (e.g., Box 12, Box 14), will enable the Sub-Code drop-down box.

#### APTAWEB-3150: Date Drop-Downs Return to Deduction Assignment Page

In a previous update of AptaFund, the drop-down menus in the Deduction Start Date and End Date fields were removed. In their places, users could choose a date from a popup calendar or type in a new date. Due to customer requests, the drop-downs have returned. Users can now choose the Pay Period Start and Pay Period End Dates from the drop-down, or can type in a specific date, or can choose a date from the popup calendar. This allows for all types of input in these fields.

#### APTAWEB-3193: Fixed Sequence Error when Editing Hours in Preview Net Pay

Removed a "Sequence Error" when users try to edit hours on the *Preview Net Pay* grid on the *Deduction Assignment* page.

#### **APTAWEB-3242: Deduction Assignment Page Cleanup**

Moved boxes and buttons around on the *Deduction Assignment* page to make them easier to follow.
