

Harris School Solutions has an issue tracking system, named JIRA, to monitor program enhancements and defects. You are able to reference these issue numbers through Harris eSupport. The APTAWEB numbers refer to the issues in JIRA that were resolved in this release.

Improvements

- ** Administration > Rollover Dashboard: Added the option to consolidate the rollover tasks for Employee Jobs. Consolidated tasks are added to the job queue as a unit, and they are run in sequence. APTAWEB-8108, APTAWEB-8208
- General program
 - AptaFund Menu: Improved the loading time for all pages. As a result, if a user's permissions to menu items are changed, the user will need to log out and back in again in order to see the changes. APTAWEB-8391
 - Collapsed panels: Panels that were collapsed by default when the window opens are now expanded by default in the following windows: — APTAWEB-8100
 - A/R > Bill Schedules > Bill Schedule Detail: Other Specs

 - Combo box (pull-down lists): Improved the performance of these fields to better keep up with the user's typing speed where there are long lists for example, account codes, vendors, and employees. APTAWEB-8459
 - Grids: Improved loading time for grids by downloading only 500 records at a time for pinned filters and filter popup. APTAWEB-8633
 - Reports: Improved time to generate reports. APTAWEB-7967
- **My AptaFund**: Added two new links to the Help section *Create a new AptaFund Support Ticket* and *Access the AptaFund Support Website*. The first link opens a form to create an email for Support, while the second link opens the Support website. Also added these links to the Dashboard in the Quick Links section. - Contact Management: Shared column is now read-only and indicates whether or not the address is shared. APTAWEB-4064
- Grid filters: Fixed a bug causing exception errors when using the multi-select feature. APTAWEB-8715
- Human Resources > Employee Jobs > Approve Jobs: When you're allowed to edit the encumbrance transaction date, the date you enter is now correctly saved in the GL Encumbrance Journal. APTAWEB-8481
- Payroll
 - Employee Payroll Information > Rollover Leave Balances: The rollover now works correctly when no employee groups have been set up. APTAWEB-7710
 - Manage Payroll: Payroll registers are now correctly calculating daily jobs. APTAWEB-8566
 - Payroll Voucher Management > Rollover Payroll Vouchers: Vouchers with negative or zero-sum liabilities on a register when the cycle = Next will roll without error. APTAWEB-7596

 - Approval History: New purchase requisitions are no longer included in Approval History. APTAWEB-8467

- Purchase Order > Rollover PO: Fixed an error caused when the user tries to roll a PO that has already been rolled from the previous fiscal year. The user will now receive the following message: "Cannot roll over PO because it has already been rolled from the previous FY.
