GL Normal Screen - Enhanced Account Code Drill-Down: Based on feedback from the Idea Portal, we have improved the review process for account codes, budgets, and transactions, new functionality has been added to the GL Normal screen. Account codes are now hyperlinked—clicking a hyperlink opens a pop-up displaying transactions and their associated sources. Users can further drill down into these sources, including Purchase Orders, Payroll Register, Payroll Liability Vouchers, and Cash Receipts,

enabling detailed review of Revenue, Expenditure, and Payroll account codes. See Tech Doc
