Colorado December Staff Assignment Report: A new CDE Staff Assignment file for the 25-26 academic year has been developed. This file is designed to meet the requirements for the Staff Interchange. This update ensures compliance with the latest reporting requirements and includes a functional hyperlink for easy editing.

Colorado December Staff Profile Reporting: Staff Profile report for the 25-26 academic year has been created, removing fields previously included in the Staff Evaluation report. Reports

APTAFUND-3431

Benefit Management Census Report: The Benefit Management Census Report has been updated to include Social Security Number and Email fields. This change accommodates the new template requirements from American Fidelity, improving compatibility with their benefits and census system.

APTAFUND-4005

Benefit Management Report: The Benefit Management Report has been updated to include the employee names on the Benefit File Information Tab. Previously, this information was only available on the Census File Information Tab, but it has now been added to improve data consistency and accessibility across the report.

APTAFUND-3389

Payroll Voucher Form: The Payroll Register Voucher Form has been enhanced with several improvements. These include using fiscal year dates instead of period dates, multi-select functionality for registers, and customizable signature lines and text.

Ability to separate vendor payments within the same voucher: Per client feedback in the Idea portal, a new 'Separate Payment' checkbox has been introduced in the Vendor Invoice Detail and Edit Invoice screens. This feature allows users to specify whether a check

should be combined with other checks from the same vendor or kept separate.

PA PSD Look-up: The Pennsylvania Location Code Lookup has been upgraded from LCS to SLS service. This update supports a more flexible location code format, less data entry by the client and confirmation of PSD code correctness when look-up is performed.

Manage Employee Filters: Per client feedback in the Idea Portal, new fields have been added to the Manage Employees section for improved sorting and reporting. Users can now filter and sort by Social Security Number and Rehire Date, enhancing data management capabilities.

APTAFUND-4222

Manage Employees Rehire Date: Per client feedback in the Idea Portal a new Rehire Date field has been added to the Manage Employees section. This field will be displayed in the grid, searchable in quick search, and located near the Hire and Termination dates, improving employee record management.

Payroll Payment Plans: Per client feedback in the idea portal, A new feature has been added to the payroll configuration, allowing users to set a default Payment Plan in HR Configuration. This improvement streamlines the process of setting up new salary positions by automatically populating the payment plan for the Edit Payment Plans popup.
